MAJOR PROJECTS THROUGHOUT CAREER

1/2019 - I was identified by the director of Integrative Medicine at Columbia University as a valuable resource in teaching yoga to cancer patients and asked to sit as a board member in a special interest group concentrating on yoga for cancer patients as a part of the Society of Integrative Oncology (SIO). This special interest group is not only a resource to other yoga instructors and patients but also a portal to create evidence-based curriculum in yoga for cancer patients.
